The meeting was opened with members reciting the Pledge of Allegiance.

Minutes of the March 25, 2019, regular meeting was provided to each Council member prior to the meeting and approved as written.

Matt Fiedler was present to inform council of the happenings of his scout group. He and the scouts will attend a future meeting to request permission from council to maintain and camp on the Buckeye Trail within the Village.

Council agreed to contact Paulding Putnam COOP to check into a 10year 0% loan for the extension of sanitary north along Progressive Drive. Mayor Miller will contact them.

Mr. Miller reported that Joel from Microtonix is working on updating the internet connection at the Municipal Center, quoted upgrades and additional equipment cost of \$1,035.00.

Mr. Moreno reported that he and Barry surveyed the Village for paving and crack sealing for future budgeting. He also talked to AEP and they have no time frame for extending power north on Progressive Drive. AEP will be contacted to see how many street lights will be needed on Progressive Drive. He suggested not selling extra property north of Mike Hohlbein's at this time.

Dan Honigford informed Council that the OVFD is working on the landscaping in front of the firehouse and will be moving the gas lantern. The glass on this lantern will be cleaned or replaced. Ottoville Concrete Solutions will be doing the cement work.

It was discussed that there are excess cats roaming the Village. Research will be done to see what can be done to reduce this population.

Board of Public Affairs members Phil Hilvers & Dan Honigford reported from the board meeting:

- > An agreement was signed with EJ Prescott to purchase parts.
- A quote and contractor is being obtained to replace the 30-year-old flights drives on the settling tank.
- Water tower inspection is to be done this summer.
- > #7 well will have the line flushed with chlorine when the weather dries, and put in service
- > Chad has agreed to assist with summer mowing instead of hiring temporary help
- > Rhodes College has an apprentice program for wastewater at no cost
- Water taps will be located and documented on the GIS by June
- > Budgeting the replacement of seven valves in 2020

Water line loops were discussed. To prepare for the Walnut Street/S. East Canal loop Mr. Moreno moved to approve tapping a valve and stub line into the waterline on Walnut Street at Sixth Street, second by Mrs. Hoersten. Vote: Leis, yes; Moreno, yes; Markward, yes; Hoersten, yes: Miller, yes; & Byrne, yes.

At 8:09 Mr. Byrne exited the meeting.
