Resolution 2019-07 Resolution authorizing Mayor to prepare and submit an application to participate in the Ohio Public Works Commission (OPWC) State Capital Improvement and/or Local Transportation Improvement Program(s) and to execute contracts as required (Second Street Storm Sewer) was read. Mr. Moreno moved to accept Resolution 2019-07 as read second by Mr. Miller. Roll call vote: Markward, yes; Moreno, yes; Hoersten, yes: Miller, yes; & Leis, yes.

Paving the Ottoville Fire Department parking lot was discussed. Cement around the firehouse is deteriorating so council felt this should be repaired prior to paving. After discussion council felt it would make more sense to pave Albert Drive this year and the firehouse parking lot next year after cement repairs are finished. Ward Construction will be contacted for a quote for Albert Drive and permission to change these projects.

Solar panels for the water & wastewater plants were discussed. Mayor Miller will check to see if this is possible.

Mr. Leis reported that the park walk path paving will be done when the pavers come to do the paving in the Village. He also noted that when Walnut Street paving is done, the manholes would be replaced with "Mr. Manhole" instead of placing risers on the existing manholes. Council felt this would be a cleaner way to do the manholes.

Mr. Moreno reported that the Maumee Watershed agreement for the walking path in the park will be sent to Mr. Army with the Maumee Watershed, to be approved. He then moved to approve Mayor Miller sign this agreement once it is approved by the Army Corps of Engineers. Mr. Leis seconds this motion. Vote: Markward, yes; Moreno, yes; Hoersten, yes: Miller, yes; & Leis, yes.

A quote will be obtained to remove a tree at the corner of Fourth & S. East Canal Streets.

Board of Public Affairs members Phil Hilvers & Dan Honigford reported from the board meeting:

- Water towers were inspected. The video shows the 200,000 gallon tower may need some recoating.
- > Well #7 has been chlorinated, pumped, and tested still noting sulfur. It is online and will be used by itself chlorinating prior to use.
- > Council was informed of a letter received from the Ohio EPA on violations with our utilities. (hydrant at cemetery will be capped off, seals on well caps will be changed, backflow preventers monitored)
- No information was received to replace the 30-year-old flight drives on settling tank
- No. 3 drive on sewer pump needed reprogrammed and a manual override installed.

Chunks of cement still need removed from the "Pease Property" on South Otto Street. The owners will be contacted to remove this.

The Solicitor discussed a letter requested to be sent to a property owner who has yet to file their Village income taxes.

With no further business meeting was adjourned at 8:45 p.m.
