Resolution 2019-13 Then and Now purchase order with Stolly Insurance Group for property and liability insurance cost of \$15,132.00 was read. Mr. Leis moved to approve Resolution 2019-13 as read second by Mr. Markward. Roll call vote: Leis, yes; Byrne, yes; Markward, yes; Hoersten, yes; Miller, yes; & Moreno, yes.

Then Mr. Leis moved to pay Stolly Insurance Group \$15,132.00 second by Mrs. Hoersten. Vote: Leis, yes; Byrne, yes; Markward, yes; Hoersten, yes; Miller, yes; & Moreno, yes.

One bid for refuse hauling was received from Ryan Lassiter dba Real Waste Disposal, LLC. Resolution 2019-14 a resolution granting a franchise for the collection of garbage, trash, rubbish, and refuse from the residential and commercial areas of the Village of Ottoville was read. Mr. Leis moved to accept Resolution 2019-14 as read second by Mr. Moreno. Roll call vote: Leis, yes; Byrne, yes; Markward, yes; Hoersten, yes; Miller, yes; & Moreno, yes.

Chief Herrick was present to comment on a mock crash that was held at school. He also stated that he has been keeping an eye on after school traffic and has given some verbal warnings. A part time officer has resigned. Council requested training and quarterly meetings for officers continue.

Brian Goubeaux Choice One Engineering was welcomed to the meeting. Barry Koester Street Supervisor was also present. They informed council of the project specs and changes for the Main Storm Line project. This project will be advertised in the next two weeks with bids opened on November 20, 2019 at 10 am.

Board of Public Affairs members Phil Hilvers & Dan Honigford reported from the board meeting:

- The 200,000 gallon water tower internal sand blasting & recoating will be done in 2020 year. Quote received for \$49,900.00.
- > The issue with #3 drive on the pump shutting off on weekend nights has been resolved. AEP changes voltage on weekends so this drive has been reprogrammed to accommodate.
- ➤ Blower motor #2 blew two 100 amp fuses. Motor was changed out.
- > Well #7 will be flushed again to try to remove sulfur. Well #4 & #6 are keeping up with Village usage.
- > 19 loads of sludge were hauled.
- > Still checking on information to replace the 30-year-old flight drives on the settling tank.

The Mother's Club has announce that they have \$25,000.00 they would like to use to finish the south end of the park walk path.

Mr. Moreno informed all that the park carnival was very successful the last couple years.

Council decided not to make any plans for the electric or sanitary on Progressive Drive until the property owners inform them that they need it.

The Solicitor reported that Aaron Burgei's "first right of refusal" contract has been signed and recorded. She also noted the receipt of "Opioid lawsuit" paperwork. No action needed at this time.

The resolution prohibiting street parking of campers was discussed noting a camper that has been along the street for a month. This resident will be served with the resolution.

With no further business meeting was adjourned at 8:15 p.m.
