Brian Goubeaux Choice One Engineering was welcomed to the meeting. He informed all that pollution insurance was required in the bid documents for the Main Storm Line project and Miller Contracting Group does not have this. Council felt Miller's should have this insurance to do this project. After discussion Mr. Miller moved to require Miller Contracting Group purchase pollution insurance for the Main Storm Line project, second by Mrs. Hoersten. Brian also presented council with the contract for engineering services for the Max & Second Streets storm projects, total cost \$39,435.00. Ottoville Volunteer Fire Department Chief Josh Kahle was present to inform council of the election of new officers. Josh Kahle Fire Chief, Brian Sheets Vice Chief, Derek Ricker Captain Secretary, Evan Laudick Captain Treasurer, Gary Wurst & Steven Eickholt are Lieutenant training officers. Justin Laudick has joined the fire department as a trained fireman. The OVFD currently has 26 active firemen, down from the maximum amount allowed of 36. - > Recommend Dan Honigford fill the empty BPA board seat
- Steve & Chad attended seminar. Ohio EPA recommends having a reserve for capital
