Fire Department

- The Fire Department will be posting soon for new member applications

- Mr. Moreno moved to approve the Ottoville Volunteer Fire Department FEMA 2021
 Assistance to Firefighters Grant of \$140,012.12; \$133,344.78 in federal funding to
 purchase SCBA's with a 5% match of \$6,667.24, which will be reimbursed by the
 townships, seconded by Mr. Leis. Vote: Miller; yes, Moreno, yes; Leis, yes; Honigford,
 yes; Petrick, yes, and Brickner, yes.
- Notice of Bid for the SCBA's will be in the Putnam County Sentinel October 5, 2022 and October 12, 2022.

BPA Report – Fiscal Officer reported

- The radiator on generator at WWTP was replaced on August 31.
- Phone company is done running fiber to water plant; now waiting on Schweller Electric to complete telemetry installation on the water towers.
- Rotating Assembly for pump #3 was rebuilt, will install when flows at the WWTP are lower. Plan on doing the same for pump #1 after the first of the year.
- Meter reading for 3rd quarter has been completed.
- Will flush hydrants the first week of October.
- Will drain and clean the clear wells at the plant the 2nd week of October; they are cleaned every other year.

- Liquid engineering is behind schedule, they are looking at October to get the water towers cleaned and inspected. If the weather turns bad before they get here, we will be first in line next spring.
- Chris Hunt is looking into grants for the potential clarifier project.
- Well #7 is too high in sulphur to put into the village water system. Possibly pull pump up 50' or camera to see if it's possible to see where the sulphur is coming from.
- Wells #4 and #6 are keeping up well currently.
- Talk with 120 Water Co. to possibly verify the lead/copper lines inside/outside of homes & businesses as per the EPA's deadline of October 2024.

- Ms. Brickner moved to approve the semi-annual transfers of \$2,000 to water reserve; \$4000 to sewer reserve; \$2500 to Police from the general fund, seconded by Mr. Leis. Vote: Miller; yes, Moreno, yes; Leis, yes; Honigford, yes; Petrick, yes, and Brickner, yes.
- Mr. Moreno moved to approve \$14,000 additional appropriations for the water department, seconded by Mrs. Petrick. Vote: Miller; yes, Moreno, yes; Leis, yes; Honigford, yes; Petrick, yes, and Brickner, yes.
- Ms. Brickner moved to approve \$22,000 additional appropriations for the sewer department, seconded by Mr. Miller. Vote: Miller; yes, Moreno, yes; Leis, yes; Honigford, yes; Petrick, yes, and Brickner, yes
