- Mr. Miller moved to suspend the rules and declare Resolution 2022-07, Temporary Appropriations Resolution, an emergency and approve Resolution 2022-07 seconded by Mr. Moreno. Roll Call Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.
- Informed council Fiscal Officer reduced the Capital Fund 4901 appropriations by \$53,930 due to having to reduce the revenue last month.
- Also informed council Fiscal Officer reallocated the paint & paint sprayer for the fire hydrants from the Water Department to the Eagle Scout fund.
- Fiscal Officer will look into 'evergreen contract agreements' for Library, Lions, Chamber, EMS, Mother's Club so the village does not have to renew annually.
- Mr. Moreno moved to transfer \$50,000 from the general fund to the street fund for yearly expenses, seconded by Mr. Miller. Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.

Mr. Joe Moreno

- Income Tax
 - Ottoville has the same process as neighboring villages and is following the Ordinance.
 - It has been noted that taxpayers are ignoring multiple letters from the income tax department.
 - O The state auditor states villages must charge late fees and penalties.
 - The distance the police travel to deliver tax letters is at the discretion of Police Chief.
- Mr. Moreno moved to go to executive session at 7:55 pm including Council, Solicitor, and Mayor, to consider the appointment, employment, dismissal, discipline, promotion, demotion, or compensation of a public employee or official, seconded by Mrs. Petrick. Roll Call Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes. Regular meeting resumed at 8:10 pm.
- Mr. Moreno made a motion to give employees including Supervisor of Village Personnel and Contract Cleaning a 3% raise and change the vacation schedule as follows: 1-4 years 2 weeks; 5-9 years 3 weeks; 10 plus years 4 weeks, seconded by Ms. Brickner. Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.
 - Special Meeting to accept and approve pay increase resolution scheduled for Thursday, December 22, 2023, at 6:00 pm.

With no further business, the meeting was adjourned at 8:16 p.m.
