The meeting was opened with members reciting the Pledge of Allegiance.

The January 23 meeting minutes were provided to each Council member prior to the meeting and approved as written.

Mr. Moreno moved to approve bills presented for payment (see register attached), seconded by Mrs. Petrick. Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.

Fire Department

- Would like to meet with Fire Board to discuss purchasing policies and guidelines.
- Mr. Moreno made a motion to approve the VFIS Fire Department accidental and sickness policy and each fireman will contribute \$1.00 towards the policy premium seconded by Ms. Brickner. Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.
- Chief will look at the heat in the fire building, possibly lower it because the last natural gas bill was \$881.50 for January/February.

BPA

- 3 quotes from Liquid Engineering to have the water towers inspected were presented.
 - a. \$4705 was obtained January 2022 for cleaning and inspection but Liquid Engineering could not fulfill because of manpower shortage.
 - b. \$3500 for inspection only not cleaning obtained December 2022 via ROV (Remote Operated Vehicle).
 - c. \$7965 obtained January 2023 for cleaning and inspection.
 - i. Mr. Davies made a motion to check if Liquid Engineering will honor the January 2022 \$4705 quote. If unavailable go ahead with the \$3500 ROV inspection only of both towers seconded by Mr. Calvelage. A vote of three yeses passed this motion.
- 2 quotes for the painting of the Ottoville Commerce Park water tower were presented.
 - a. Leary Construction \$64,984.06
 - b. Pittsburgh Tank \$84,500
 - i. Mr. Davies made a motion to table until next month seconded by Mr. Calvelage. A vote of three yeses passed this motion.
 - ii. The project could possibly be postponed for a year, but rusting has started.
 - iii. Mr. Helms will help check on other companies since the quotes were higher than expected.
- State Route 66 pump station was down for a few days due to a blockage in the line. It is now up and running.
- Schweller continues working on the VPN (wireless water tower) project.
- Information has been submitted to 120 Water regarding the lead and copper project. We are waiting to hear back from them for the next steps.

- Ottoville School had a water leak due to a valve for the fire suppression system in the athletic complex. They have asked for a credit for the sewer portion of the utility billing since it didn't run through the sewer. It is thought that the fire suppression systems are not metered; this will be checked into.
- Mr. Davies made a motion to credit utility late fees if payment comes in after the due date but is postmarked on the due date or before seconded by Mr. Helms. A vote of three yeses passed this motion.
- 2 residences, account numbers 220 and 266, asked for the vacation RTS credit as noted in BPA minutes July 28, 2014.

Fiscal Officer

- Fiscal Officer attending the Local Government Conference March 27 29. March council meeting rescheduled for March 20 at 7:00 pm.
- Mr. Moreno moved to approve ACII fees of .8% to pay Microtonix bills via ACII, seconded by Mrs. Petrick. Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.
- Fiscal Officer will supply Finance Committee with Appropriation Supplements quarterly for review.
- Tawa Mulch completed the mulching but obtained damage to the hammers and cutters on their grinder due to a large granite rock in the brush pile. They asked that the village cover half the repair cost of \$642.00. Mr. Moreno moved to approve paying the additional \$642 for repairs seconded by Mr. Miller. Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.

Resolution 2023-02, A Resolution Directing the Expenditure of Public Funds for a Proper Public Purpose was emailed prior to the meeting. Mr. Moreno moved to approve the 2nd reading with one amendment suggested by Mrs. Von Sosson; cite the reference 'proper public purpose' seconded by Mr. Honigford. Roll Call Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.

Mr. Miller moved to approve the 1st reading of Resolution 2023-03, A Resolution requesting the Putnam County Auditor certify to the village of Ottoville the total current tax valuations and the dollar amount of revenue that would be generated by the tax levy, seconded by Mr. Buss. Roll Call Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.

Mr. Joe Moreno

- Splash Pad update
 - Met with Chamber of Commerce; they will be getting Council additional information so Council can make an informed decision to approve or not the construction based on expenses, water usage, etc. Also discussed location of potential project within the village.
- Network upgrade
 - o Pugsley Audio and Microtronix submitted quotes.
 - Microtronix did not include labor or additional material cost needed in quotes, so these quotes seem lower.
 - o Pugsley will integrate with the park's camera system.
 - O Based on these findings, and after some discussion, Mr. Miller moved to accept the Pugsley quote to upgrade the building's network for \$3,870.62 seconded by Ms. Brickner. Vote: Miller, yes; Brickner, yes; Moreno, yes; Honigford, yes; Petrick, yes; and Buss, yes.
- Will invite Brian with Choice One to March's council meeting to discuss storm sewers;
 Second Street and Red Maple Court. Would like to try for the county level OPWC grant.
- Discussion about other committees/departments attending council meetings regularly.
 Mr. Moreno will reach out to BPA to invite them to the monthly council meetings.
