The December 11 and January 9 meeting minutes were provided to each Council member prior to the meeting and approved as written.

Mr. Moreno moved to approve bills presented for payment (see register attached) with the date correction, seconded by Mr. Buss. A vote of four yeses passed this motion.

Mr. Devin Ricker and Mr. Jim Niedecken were in attendance to discuss the sidewalks, curbs, and trees along their properties. They would like the village to help finance the removal/replacement. Mr. Honigford will meet with residents to look at both properties when the weather permits then report to Council a recommendation.

Mr. Dave Kortokrax presented his duplex plans in the Bendele Triangle Subdivision and asked for a variance for the side yard next to the cul-de-sac. After reviewing Zoning Ordinance 288, it was determined the structure was within the setback requirements and no variance was needed.

- Currently, there are 25 active firefighters.
- Reminder to the OVFD, the VFIS Accidental & Sickness Insurance Policy will renew March 1. The village will need the firefighters, active and inactive reserve's, contributions.
- The American Rescue Relief Fund moneys for the fire department in the amount of \$30,522.35, to date, is unspent. Chief Ricker has been in contact with the fireboard concerning this. They are looking at turnout gear and equipment.
- Inquiry: where does the village get its Narcan. Project Dawn distributes it for free. Village gets it through the county and does not pay for it.
- Discussion about the school fire lane. Chief Ricker will talk to the school and if necessary, Council can coordinate our police department to help enforce the no parking in these areas.

BPA Report presented by Fiscal Officer

- Mr. Helms nominated Mr. Calvelage for BPA president seconded by Mr. Davies. The nomination passed unanimously.
- Jim Miller's property east of Black Angus is hooked up to water and sewer. The tap application was presented and approved.
- The muffin monster was delivered. The Henry P. Thompson Co. will be completing the installation. It is anticipated to be complete in the next week or two.
- A couple of minor issues with the cold weather. Everything was resolved relatively easily.

- Schweller Electric and Craun Liebing will be replacing the failed control board at the school pump station when the weather cooperates. We are presently running off the floats.
- 120 Water
 - o A few postcards are still coming in, not optimistic about receiving many more.
 - o 120 Water has offered a lower price to keep their services. It was agreed we no longer need them at this time.
 - October 16, 2024, is the Ohio EPA's deadline for submission. We are confident we will be compliant.
- A couple of water main breaks in the month of December, one on Christmas Day. Those were our only two main breaks in 2023. There are some service line leaks on the customer side.

Fiscal Officer (FO)

- BWC audit
 - O Auditor advised that contractors without BWC coverage potentially can come back on the village's coverage. She stated the COI liability doesn't protect the village. FO emailed Stolly Insurance for comment and will keep council abreast. Council agreed to continue as normal with local contractors even if they do not have BWC coverage and the FO should try to stay ahead of the expiring COI's on record.
 - O Police freelancing will fall under the village's policy under a new ruling.
 - o Inactive Reserve Firemen are currently not covered under the BWC policy. Chief Ricker advised that the bylaws may be updated at the February fire meeting concerning the inactive reserve. Council will revisit this discussion after this meeting.
- Would like to proceed with the list of suggested ordinances to repeal. FO will email the list to Mr. Buchholz for review.

Other Business

- Personnel Committee interviewed two candidates for the open council seat. Mr. Moreno made a motion to nominate Mr. Jim Wannemacher seconded by Mrs. Zeller. Mr. Honigford made a motion to close the nominations seconded by Mr. Buss. A vote of 4 yeses passed this motion.
