The April 22 regular meeting and May 9 special meeting minutes were provided to each Council member prior to the meeting and approved as written.

Mr. Moreno moved to approve bills presented for payment (see register attached), seconded by Mrs. Zeller. A vote of six yeses passed this motion.

## BPA presented by Fiscal Officer

- ART was in town lining manholes. Utility Department determined no additional manholes will need to be lined in 2025.
- No quotes have been received yet for the concrete pads under the Second Street water tower or tuck points of the water plant.
- The generator at the WWTP was serviced; 2<sup>nd</sup> biannual service will be in October/November.
  - a. The fuel filter stopped leaking. The tech did change out an O-ring in the hopes this is all that was needed.
- Chris Hunt with Hunt Engineering has been on site a few times in the last several weeks to take some elevations and do some planning for the clarifier project at the WWTP. He will be developing a print for everyone to view.
- Looking into rebuilding the rotating assembly for pump #1 at the WWTP.
  - a. Craun Liebing will give a quote to rebuild.
  - b. A new assembly is approximately \$6500.
  - c. This is the last of the 3 pumps that need a new rotating assembly.
- PSI has begun constructing their new building. No water or sewer taps have been made yet.

## Fiscal Officer (FO)

- Mr. Honigford made a motion to increase the capital appropriation fund and the capital certificate of estimated resources \$435,860 for the design plan costs for the sewer clarifier project seconded by Mr. Moreno. A vote of six yeses passed this motion.
- Mr. Wannemacher made a motion to approve FO to renew CDs at the best rate each renewal date, seconded by Mrs. Petrick. A vote of six yeses passed this motion.
- Clarification on residential CRA's, they do not include additions or remodeling of garages only, must be the dwelling.
- Mr. Wannemacher made a motion to table the AEP Energy Professionals renewal contract offer and have FO ask about 12-month options seconded by Mr. Honigford. A vote of six yeses passed this motion.

- Quote presented by J&M Excavating for \$3495 to remove and replace sections of sidewalk at 223 East Canal St and 147 N East Canal Street. Mr. Wannemacher made a motion to accept the quote seconded by Mr. Buss. A vote of six yeses passed this motion.
  - o Street Maintenance will remove the tree at 223 East Canal Street.
- The Street Department also looked at a tree located on the corner of S East Canal and Fifth Streets and recommended it coming down. A quote will be obtained by the Street Department.
