

ORDINANCE 8
TO PROVIDE FOR THE PERFORMANCE OF TWO
DAYS LABOR UPON THE PUBLIC STREETS, ALLEYS
AND HIGHWAYS OF THE INCORPORATED VILLAGE
OF OTTOVILLE, PUTNAM COUNTY, OHIO.

BE IT ORDAINED BY THE COUNCIL OF THE INCORPORATED VILLAGE
OF OTTOVILLE, PUTNAM COUNTY, OHIO.

SECTION ONE: THAT ALL ABLE BODIED MALES PERSONS BETWEEN THE AGES OF TWENTY ONE AND FIFTY-FIVE RESIDENTS OF SAID VILLAGE EXCEPT SUCH AS EXEMPT FROM THIS PERFORMANCE OF SUCH LABOR BY THE LAWS OF OHIO. SHALL BE LIABLE ANNUALLY TO DO AND PERFORM BY THEMSELVES OR SUBSTITUTES TWO DAYS LABOR ON THE VILLAGE STREETS, ALLEYS, AND HIGHWAYS OF SAID VILLAGE UNDER THE DIRECTION OF THE STREET COMMISSIONER THEREOF.

SECTION TWO: IF A PERSON WARNED OUT AS HEREIN AFTER PROVIDED SHALL PAY TO THE STREET COMMISSIONER OF SAID VILLAGE THE SUM OF THREE DOLLARS WITHIN FIVE DAYS AFTER BEING NOTIFIED BY THE STREET COMMISSIONER THE SAME SHALL RECEIVE IN LIEU OF SAID TWO DAYS LABOR AND SHALL BE EXEMPT WHERE SAID LABOR WOULD HAVE BEEN APPLIED.

SECTION THREE: THE STREET COMMISSIONER SHALL ORDER OUT EVERY SUCH PERSON RESIDENT IN SAID VILLAGE BETWEEN THE FIRST DAY OF APRIL AND FIRST DAY OF SEPTEMBER ANNUALLY AND DIRECT HIM TO DO AND PERFORM THE WORK OF ONE SAID ON THE PUBLIC STREET, ALLEY AND HIGHWAY OF SAID VILLAGE. THE ORDERS SHALL BE GIVEN TO EACH PERSON FIVE DAYS PRIOR TO THE TIME APPOINTED FOR THE PERFORMANCE OF THE LABOR, EITHER PERSONALLY BY WRITTEN OR PRINTED NOTICE LEFT AT HIS USUAL PLACE OF RESIDENCE AND IF ANY PERSON SO NOTIFIED WHO IS LIABLE TO PERFORM SUCH LABOR REFUSES AND NEGLECTS TO ATTEND AND PERFORM SUCH LABOR EITHER BY HIMSELF OR SUBSTITUTE TO THE ACCEPTANCE OF THE STREET COMMISSIONER OR HAVING ATTENDED, REFUSES TO OBEY THE REASONABLE DIRECTION OF SAID STREET COMMISSIONER, HE SHALL BE LIABLE TO THE AMOUNT ALLOWED FOR TWO DAYS LABOR TO BE RECOVERED BY ACTION BEFORE THE MAYOR OF SAID VILLAGE. AT THE SUIT OF THE STREET COMMISSIONER THEREOF AND THE AMOUNT SO RECOVERED SHALL BE EXPANDED BY SAID COMMISSIONER UPON THE STREETS, ALLEYS AND HIGHWAYS OF SAID VILLAGE UNDER THE DIRECTION OF SAID COUNCIL.

SECTION FOUR: THE STREET COMMISSIONER SHALL AT THE REGULAR MARCH MEETING OF COUNCIL RETURN A FULL AND TRUE

LIST OF THE NAMES OF ALL PERSONS WHO HAVE BY HIM BEEN ORDERED TO PERFORM SAID TWO DAYS LABOR PARTICULARLY STATING THEREIN WHO HAVE IMPLIED WITH THE PROVISIONS OF THIS ORDINANCE AND WHO HAVE NEGLECTED AND REFUSED TO COMPLY THEREWITH TOGETHER WITH A STATEMENT OF ANY AND ALL JUDGEMENT HE MAY HAVE RECOVERED BY REASONS OF THE PROVISIONS HEREIN.

SECTION FIVE: THIS ORDINANCE TO TAKE EFFECT AND BE IN FORCE FROM AND AFTER THE 13 TH DAY OF MAY A.D. 1891.
