ORDINANCE 29

FIXING THE AMOUNT OF THE BONDS TO BE GIVEN BY THE OFFICERS OF THE VILLAGE OF OTTOVILLE OHIO, AND SPECIFYING THE SALARIES THEY SHALL RECEIVE FOR THEIR SERVICE

Section 1 Be it ordained by the council of the Village of Ottoville, Ohio, that the mayor of said village, before entering upon the duties of hisoffice shall execute a bond payable the the State of Ohio, and conditioned according to law in the penal sum of five thousand (\$5000.00) dollars. That the mayor shall receive as his salary the sum of seventy-five (\$75.00) dollars per annum, payable semi annually out of the treasury of said village, providing that he shall receive no extra compensation during his term of office and shall deposit each month into the corporation treasury all money's collected in prosecution of criminal cases by means of the village ordinances, and from a monthly report to the council of fines and moneys from criminal cases, licensed, etc.... collected and shall draw from all ordinances, resolution, and other documents requested or required by the council on behalf of the village free of charge.

Section 2 That the clerk of said village before entering upon the duties of his office, shall execute a bond payable to the State of Ohio, and conditioned according to law, in the penal sum of one thousand (\$1000.00) dollars and that he shall receive as his salary the sum of fifty (\$50.00) dollars per annum, payable semi-annually out of the treasury of said village.

Section 3 That the treasurer of said village before entering upon the duties of his office shall execute a bond payable to the State of Ohio, and conditioned according to law in the penal sum of two thousand (\$2000.00) dollars and the he shall receive as his salary the sum of thirty-five (\$35.00) per annum payable semi-annually out of the treasury of said village.

Section 4 That the Marshall of said village before entering upon his duties of his office shall execute bond payable to the State of Ohio, and conditioned according to law in the penal amount of one thousand (\$1000.00) dollars, and that he shall receive as his salary on hundred (\$100.00) per annum, payable quarter annually out of the treasury of said village.

Section 5 That each councilmen shall receive as his salary on (\$1.00) dollars for each regular meeting paid semi-annually out of the treasury of said village, not to exceed twenty four meetings in one year, and unless sick must be present to be entitled to same

Section 6 That the health officer of said village shall receive as his salary the sum of ten (\$10.00) dollars per annum, payable annually out of the treasury of said village.

Section 7 That the chief of fire department of said village shall receive as his salary the sun of ten (\$10.00) dollars per annum payable annually out of the treasury of said village.

Section 8 That any or all of said officers shall be required to give additional or new bonds whenever the bonds so given herennder shall be inadequate or the sureties thereon are deemed insufficient.

Section 9 That all ordinances heretofore passed in the village of Ottoville, Ohio be and the same are hereby repealed.

Section 10 That this ordinance shall take effect and be in full force from and after the Tuesday in January A. D. 1908.
