ORDINANCE # 167

AN ORDINANCE PERTAINING TO WATER AND SEWAGE CHARGES AND REGULATIONS AND DECLARING AN EMERGENCY;

BE IT ORDAINED BY THE VILLAGE COUNCIL OF OTTOVILLE OHIO;

Section 1, That inside the Village limits, the following rates are established for metered water users.

The water usage rate is set at \$1.00 per 1,000 gallons, with a minimum charge of \$4.00 per month.

The sewage user charge, based on the water usage, is set at \$2.56 per 1,000 gallons, with a minimum charge of \$10.60 per month, plus any industrial cost recovery charges that have been established.

Section 2. That inside the Village limits, for sewage users whos water usage cannot be metered or measured, the minimum monthly sewage charge is set at \$21.20 per month.

This section shall also apply to sewage users outside the Village.

Section 3. That outside the Village limits, the water usage rate for metered users is set at \$2.00 per 1,000 gallons, with a minimum charge of \$8.00 per month.

The sewage user charge, based on the water usage, is set at \$2.65 per 1,000 gallons, with a minimum charge of \$10.60 per month, plus any industrial cost recovery charges that have been established.

Section 4. That for new installations, the Village will furnish the water meter and the property owner will be responsible for the proper plumbing and installation of the water meter.

The charge for a 3/4 inch water tap is set at \$150.00.

The charge for a 1 inch water tap is set at \$200.00.

The charge for a 2 inch water tap is set at \$400.00.

That in addition to the above charges, if a water meter pit is needed, an additional charge of \$200.00 is required.

Section 5. That the sewer connection charge be calculated as follows. The charge shall be equal to the total of the minimum monthly charge of \$10.60 per month from November 1,1978 till the end of the quarter in which the connection is made. Up to a maximum charge of \$500.00 per connection.

The following is a schedule of the sewer connection charges.

Section 6. That after proper notification of the charges that are due for water and sewer services, these charges are due and must be paid by the specified date. If the charges are not paid by the specified date, a 10% penalty will be added to the charges.

A second notification will then be issued to the delinquent party stating the total charges and the final payment date. If the charges are not paid by the final payment date, the Board of Public Affairs is authorized to shut off the water to the delinquent user.

Once the water has been shut off for this reason, in addition to the previously billed charges, a \$ 10.00 service call charge must be paid befor the water can be turned on.

The Board of Public Affairs may also sue the delinquent party for past due charges, thru the Village Solicitor and the Small Claims Court, after receiving authorization from the Village Council.

Section 7. The Board of Public Affairs shall have full authority to act on individual circumstances concerning rates, penalties and other items pertaining to water and sewage services.

Section 8. That the property owner is responsible for the proper care of all equipment on the property owners side of the curb stop, including the water meter.

Section 9. That the Director of Utilities is authorized to make inspections, at the time of installation and whenever deemed necessary, of the water meters and sewer connections to make sure they are properly installed and operating according to specifications.

Section 10. That the following actions are illegal and are subject to a fine.

A. To dump or put unauthorized garbage or trash into the Sanitary Sewage System.

B. Tampering with manholes, lift stations or any Village owned equipment.

C. Turning on city water at the curb stop without authorization. The above illegal actions are subject to a \$ 100.00 fine for the first offence, and a \$ 500.00 fine for each offence thereafter.

Section 11. That each individual apartment, homestead or business is required to have its own water meter.

Section 12. That no clean water is to be run into the Sanitary Sewage System. Spoutings, roof drains, perimeter drain sump pumps are to be run on top of the ground or into the storm drains.

The Director of Utilities is authorized to make dye tests whenever deemed necessary.

Section 13. That for filling a swiming pool, a special portable water meter may be obtained from the Director of Utilities. The user will pay only the water charge for this service.

Section 14. That the various user charges as established by this ordinance are to be reviewed and adjusted if necessary, in September of each year by the Board of Public Affairs.

Section 15. That this ordinance is declared to be an emergency ordinance and shall be in effect and in full force upon the day of its passage.
