ORDINANCE # 186

AN ORDINANCE TO ESTABLISH NEW WATER AND SEWAGE CHARGES. THIS ORDINANCE DELETES AND SUPERSEDES SECTIONS 1,2,3,and 4 OF ORDINANCE # 167. AND THIS ORDINANCE IS HEREBY DECLARED AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OTTOVILLE, OHIO:

SECTION 1. There is hereby established a monthly "Readiness to serve charge", for all regular users. This is to be a monthly charge for water and sewage unless the water is requested to be turned off.

Charges for users inside the Village limits are as follows;

WATER \$4.00 per month readiness to serve charge.

WATER \$1.00 per 1000 gallons of water used.

SEWAGE charges, based on water usage.

SEWAGE \$10.00 per month readiness to serve charge.

SEWAGE \$ 2.00 per 1000 gallons of water used.

SECTION 2. That inside the Village limits for sewage users whos water usage cannot be metered or measured, The minimum monthly sewage charge is set at \$25.00 per month.

This section shall also apply to sewage users outside the Village limits.

SECTION 3. That outside the Village limits, the following rates are tablished for metered users.

WATER \$4.00 per month rediness to serve charge.

WATER \$2.00 per 1000 gallons of water used.

SEWAGE charges based on water usage.

SEWAGE \$10.00 per month readiness to serve charge.

SEWAGE \$ 2.00 per 1000 gallons of water used.

SECTION 4. That for new insatllations the Village will furnish the water meter and the property owner will be responsible for the proper plumbing and installation of the water meter.

The charge for a 3/4 inch water tap is set at \$200.00.

The charge for a 1 inch water tap is set at \$250.00.

The charge for a 2 inch tap is set at \$500.00.

The charge for a water meter pit is set at \$200.00.

SECTION 5. This ordinance is declared to be an emergency ordinance and shall be in effect and in force upon the day of its passage.

AMMENDMENT TO ORDINANCE # 186

AN AMMENDMENT TO SECTION 2. OF ORDINANCE # 186.

BE IT ORDAINED BY THE VILLAGE COUNCIL OF OTTOVILLE, OHIO;

SECTION 1. That due to the changing circumstances within the Village of Ottoville, SECTION 2. of Ordinance # 186 is hereby ammended to read as follows.

SECTION 2. That for users of the Village Sanitary Sewage System who discharge private well water into the system, There will be a minimum monthly charge of \$25.00.

For users of the sewage system who discharge private cistern water into the sewage system, there will be a minimum monthly charge of \$5.00.

Both well and cistern users shall have the option of installing a secondary meter, furnished and installed by the individual customer at his expense. Billing of the secondary meter will be for sewage rates only.

Both well and cistern users must provide for complete seperation of their water plumbing systems, or a double backflow prevention device must be installed in the Village water service line, by the customer, at his expense.

The Village requires that all new apartments, businesses etc provide for individual metering of each unit and that all existing multiple units be required to provide for individual metering when a new owner aquires such a property.

All such installations must be inspected and approved by the Village.

Readiness to serve charges, as per the larger of the meter or water
tap size are hereby established as follows;

 $\frac{3}{4}$ inch \$ 4.00 per month.

l inch \$ 8.00 per month.

2 inch \$24.00 per month.

4 inch \$48.00 per month.

6 inch \$96.00 per month.

SECTION 3. This ammendment to SECTION 2. of Ordinance # 186 shall be effective at the earliest date allowed by law.
