

ORDINANCE NO. 218

ORDINANCE ACCEPTING ANNEXATION ON APPLICATION OF
FREEHOLDERS.

To accept the application for the annexation of certain territory containing 18.05 acres of land in Monterey Township to the Village of Ottoville.

WHEREAS, a Petition for the annexation of certain territory in Monterey Township was duly filed by Elizabeth L. Miller, and

WHEREAS, the said Petition was duly considered by the Board of County Commissioners of Putnam County, Ohio, on November 21, 1988, and

WHEREAS, the Board of County Commissioners has approved the annexation of said territory to the Village of Ottoville as hereinafter described, and

WHEREAS, the Board of County Commissioners certified the transcript of the proceedings in connection with said annexation with the map to the Village Clerk who received same on NOVEMBER 21, 1988, and

WHEREAS, sixty (60) days from the date of said filing has now elapsed in accordance with the provisions of O.R.C. §709.04; now, therefore,

Be it ordained by the Council of the Village of Ottoville:

1. That the proposed annexation as applied for in the Petition of Elizabeth L. Miller and a majority of the owners of the land sought to be annexed and filed with the Board of County Commissioners of Putnam County, Ohio, on November 21, 1988, and which said Petition prayed for annexation to the Village of Ottoville, Ohio, of certain territory adjacent thereto as hereinafter described, and which said Petition was approved for annexation to the Village of Ottoville by the Board of County Commissioners on November 21, 1988, be and the same is hereby accepted. See "Exhibit A" attached hereto and made a part hereof for description to said territory.

The certified transcript of the proceedings for annexation with an accurate map of said territory, together with other papers relating to the proceedings thereto of said County Commissioners are all on file with the Clerk of this Village Council and have been for more than sixty (60) days.

2. That the Village Clerk be, and he is, hereby authorized and directed to make three copies of this Ordinance to each of

which shall be attached a copy of the map accompanying the Petition for annexation, a copy of the transcript of proceedings of the Board of County Commissioners relating thereto and a Certificate as to the correctness thereof. The Village Clerk shall then forthwith deliver one copy to the County Recorder, one copy to the County Auditor, and one copy to the Secretary of State and do all things required by law.

EXHIBIT "A"

Elizabeth Miller Anexation Platting of a part of the Northwest Quarter of Section 30, Township 1 South, Range 5 East, Monterey Township, Putnam County, Ohio and described as follows:

Commencing at the North Quarter Post of Section 30; thence South, along the Half Section Line, 640.00 feet; Thence South 88 degrees, 14 minutes, 43 seconds, West 932.46 feet to the Centerline of State Route 189; Thence North 46 degrees, 27 minutes, 21 seconds West, along the Centerline of State Route 189, 704.99 feet; thence North 42 degrees, 01 minutes, 41 seconds East 191.98 feet to the North line of Section 30; Thence North 88 degrees, 14 minutes, 43 seconds East, along the North line of Section 30, 1315.12 feet to the Point of Beginning, containing 18.05 Acres more or less subject however to all legal highways, easements and restrictions of use now on record.
