ORDINANCE NO. 286

AN ORDINANCE FIXING SALARIES, WAGES AND BONDS FOR OFFICIALS AND EMPLOYEES OF THE VILLAGE OF OTTOVILLE, OHIO.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OTTOVILLE, STATE OF OHIO, three-fourths of all the members elected thereto concurring:

SECTION I. BONDS OF OFFICERS AND EMPLOYEES: Before entering upon the discharge of their duties, the following officials and employees shall execute a bond approved according to law, in the amount set forth opposite his or her respective office or position.

SECTION III. Salaries of all officials and employees shall be paid semi-monthly, monthly, quarterly or semi-annually as determined by the Clerk-Treasurer, unless otherwise directed by Council.

SECTION IV. Council members and Board of Public Affairs members shall be allowed no more than two unauthorized meeting absences a year.

SECTION V. Employees.

A. Unless otherwise specified, each full time employee shall be entitled to two weeks (80 hours) of paid vacation after

one full year of service to the Village, and annually thereafter. A full time employee shall be entitled to three weeks (120 hours) of paid vacation after ten years of continuous service to the Village. Vacations must be taken during the period they are due.

- B. Each full time employee shall be allowed three days, paid personal leave for a death in the immediate family.
- C. Each regular employee shall be entitled to 4.6 hours of sick leave for each completed 80 hours of service. Employees may use sick leave for personal illness, or for illness in their immediate family at the discretion of the Mayor.
- D. Upon termination of employment, retirement or death, an employee shall be entitled to be paid for their lawfully accrued and unused vacation time, at their current rate of pay. An employee with eight or more years of service shall also be paid for 25 percent of their accrued and unused sick leave up to a maximum of 30 days, at their current rate of pay.
- E. Each full time employee shall be entitled to family hospital and medical insurance paid for by the Village.
- F. Each full time employee shall be entitled to the following paid holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day.
- G. All employee physicals required by the Village or by law shall be paid for by the Village.
- H. Each full time employee shall be on call twenty-four hours a day, seven days a week.

SECTION VI. All salaries and wages shall be paid and charged to one or more of the funds through which said services were rendered.

SECTION VII. All pay increases embodied in this ordinance shall commence January 1, 1998, despite the effective date of this ordinance. Future increases in pay of employees and officials may be allowed by Resolution of Council.

SECTION VIII. Ordinance Number 253 and all amendments thereto are hereby repealed.

SECTION IX. This Ordinance shall be effective at the earliest date allowed by law.
