

VILLAGE OF OTTOVILLE

ORDINANCE NO. 2008-02

**AN ORDINANCE DECLARING IT NECESSARY TO LEVY
A TAX IN EXCESS OF THE TEN MILL LIMITATION**

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the purpose of general construction requirements of said Village of Ottoville, Putnam County, Ohio;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OTTOVILLE, OHIO, STATE OF OHIO, TWO-THIRDS OF IT'S MEMBERS CONCURRING:

SECTION 1. The Village of Ottoville shall levy a tax in excess of the ten mill limitation for the benefit of the Village of Ottoville for the purpose of general construction in the Village at a rate not exceeding 1.95 mills for each one dollar of valuation, which amounts to nineteen and one-half cents (\$.195) for each one hundred dollars of valuation, for the duplicate years 2009, 2010, 2011, 2012, and 2013, and which levy is a renewal of an existing levy.


SECTION 2. The question of levying additional taxes shall be submitted to the electors of said Village of Ottoville at the general election to be held at the usual voting places within said Village of Ottoville on the 4th day of November, 2008.

SECTION 4. Said levy shall be placed upon the tax list of the current year after the February settlement next succeeding the election, if a majority of the electors voting thereon vote in favor thereof.

SECTION 5. The Fiscal Officer of this Council of the Village of Ottoville is hereby directed to certify a copy of this Ordinance to the Board of Elections, Putnam County, Ohio at least seventy-five (75) days prior to the general election and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.
