ORDINANCE NO. <u>2008-05</u>

AN ORDINANCE APPROVING, ADOPTING, AND ENACTING AMERICAN LEGAL PUBLISHING'S OHIO BASIC CODE, 2008 EDITION, AS THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF THE VILLAGE OF OTTOVILLE

WHEREAS, American Legal Publishing Corporation publishes a Code of Ordinances suitable for adoption by municipalities in Ohio.

WHEREAS, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the municipality that this ordinance take effect at an early date.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OTTOVILLE, OR TWO-THIRDS CONCURRING THERETO, THAT:

<u>SECTION 1</u>. American Legal Publishing's Ohio Basic Code, 2008 Edition, as reviewed and approved by the Council of the Village of Ottoville, is hereby adopted and enacted. Any prior version of the Ohio Basic Code which may have been previously adopted by the municipality is hereby replaced in its entirety by this Ohio Basic Code, 2008 Edition. Any editions of the Ohio Basic Code published subsequent to the 2008 Edition of the Ohio Basic Code shall automatically replace the 2008 Edition.

<u>SECTION 2</u>. In the event any ordinances and resolutions, or parts thereof, are in conflict or inconsistent with any provision of the Ohio Basic Code, 2008 Edition, as adopted in Section 1 hereof, the Ohio Basic Code, 2008 Edition shall prevail.

- (A) The enactment of the Ohio Basic Code, 2008 Edition, shall not be construed to affect a right or liability accrued or incurred under any legislative provision prior to the effective date of such enactment, or an action or proceeding for the enforcement of such right or liability. Such enactment shall not be construed to relieve any person from punishment for an act committed in violation of any such legislative provision, nor to affect an indictment or prosecution therefore. For such purposes, any such legislative provision shall continue in full force notwithstanding its repeal for the purpose of revision and codification.
- (B) This ordinance shall not affect:
 - (1) The grant or creation of a franchise, license, right, easement or privilege;
 - (2) The purchase, sale, lease, or transfer of property;

- (3) The appropriation or expenditure of money or promise or guarantee of payment;
- (4) The assumption of any contract or obligation;
- (5) The issuance and delivery of any bonds, obligations, or other instruments of indebtedness;
- (6) The levy or imposition of taxes, assessments, or charges;
- (7) The establishment, naming, vacating or grade level of any street or public way;
- (8) The dedication of property or plat approval;
- (9) The annexation or detachment of territory;
- (10) Any legislation enacted subsequent to the adoption of this ordinance;
- (11) Any legislation specifically superseding the provisions of the Ohio Basic Code.
