A Resolution to make appropriations for Current Expenses and other Expenditures of the Village of Ottoville, State of Ohio, during the fiscal year ending December 31, 2016.

BE IT RESOLVED by the Council of the Village of Ottoville, Putnam County, State of Ohio, that, to provide for the current expenses and other expenditures of the said Village of Ottoville during the fiscal year ending December 31, 2016, the following sums be and the same are hereby set aside and appropriated for the several purposes for which expenditures are to be made for and during said fiscal year, as follows, viz:

Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of Council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

This resolution shall take effect at the earliest period allowed by law.
