
Additional: Additional:

- The Friday after Thanksgiving each year shall be recognized as a Straight Time Paid Holiday
- Christmas Eve Day, unless either Christmas Eve or Christmas falls on a weekend, then the first scheduled work day after Christmas, shall be recognized as a Straight Time Paid Holiday.
- Full Time Employees shall be granted 3 "Bonus Days" to be used at their discretion, valid for the calendar year given, and may not be carried over. Follow the procedure for requesting use of a "Bonus Day" in employee handbook in Section 5.03 Paragraph B.

SECTION 2. This Resolution shall become effective upon passage and implemented January 1, 2018.


