

## Resolution 2019-06

# RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN MILL LIMITATION

Rev. Code, Sec. 5705.19, .191, .194, .21, .26, §5705.192

The Council of the Village of Ottoville, Putnam County, Ohio met in regular session on the 22th day of July 2019, at the office of Ottoville Municipal Center with the following members present:

William D. Miller

Mr. Darren Leis moved the adoption of the following Resolution:

WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Village of Ottoville, Putnam County, Ohio; therefore be it

RESOLVED, by the Council of the Village of Ottoville, Putnam County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of Village of Ottoville for the purpose of current expenses in the Village (Ohio Revised Code §5705.19 (A)) at a rate not exceeding 1.30 mills for each one dollar of valuation, which amounts to thirteen cents (0.13) for each one hundred dollars of valuation, for the duplicate years 2020, 2021, 2022, 2023, 2024, and which levy is a **replacement** of an existing levy of 1.30 mills.

RESOLVED, That the question of levying additional taxes be submitted to the electors of said Village of Ottoville at the General election to be held at the usual voting places within said Village of Ottoville on the 5<sup>th</sup> day of November, 2019, and be it further

RESOLVED, That said levy be placed upon the tax list of the current year after the February settlement next succeeding the election, if a majority of the electors voting thereon vote in favor thereof; and be it further

RESOLVED, That the Clerk of this Council of the Village of Ottoville be and he is hereby directed to certify a copy of this Resolution to the Board of Elections, Putnam County, Ohio, at least 90 days prior to the General Election and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.


