SECTION 2. The Mayor is further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance subject to the approval as to form by the Village Solicitor.

<u>SECTION 3.</u> The Village Fiscal Officer is hereby authorized and instructed to execute the certification regarding the availability of funds contained within said contract, pending verification by her of the availability of said funds.
