RESOLUTION NO. 2021-11

RESOLUTION GRANTING AUTHORIZING TO THE VILLAGE OF OTTOVILLE, OHIO TO PARTICIPATE IN THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM.

WHEREAS, Ohio's Cooperative Purchasing Act. (AM. Sub H.B. No. 100), was signed into law on December 4th, 1985; and

WHEREAS, effective March 6, 1986, Ohio's Cooperative Purchasing Act provides the opportunity for counties, townships, municipal corporations, regional transit authorities, regional airport authorities or port authorities and school districts, conservancy districts, township park districts and park districts and other authorities, to participate in contracts distributed by the State of Ohio, Department of Administrative Services, Office of Cooperative Purchasing for the purchase of supplies, services, equipment and certain materials;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF OTTOVILLE, STATE OF OHIO, OR TWO-THIRDS (2/3) OF ITS MEMBERS CONCURRING THERETO, THAT:

SECTION 1. That Jeanne M. Wannemacher, Fiscal Officer, and Ronald N. Miller, Mayor hereby request authority in the name of the Village of Ottoville to participate in state contracts which the Department of Administrative Services, Office of State Purchasing has entered into and the Office of Cooperative Purchasing has distributed for the purchase of supplies, services, equipment and certain other materials pursuant to Revised Code Section 125.04.

SECTION 2. That Jeanne M. Wannemacher and Ronald N. Miller are hereby authorized to agree in the name of the Village of Ottoville to be bound by all contract terms and conditions as the Department of Administrative Service, Office of Cooperative Purchasing prescribes. Such terms and conditions may include a reasonable annual membership fee to cover the administrative costs which the Department of Administrative Services incurs as a result of the Village of Ottoville participation in the contract. Further, that Jeanne M. Wannemacher and Ronald N. Miller do hereby agree to be bound by all such terms and conditions and to not cause or assist in any way the misuse of such contracts or make contract disclosures to non-members of the Coop for the purpose of avoiding the requirements established by ORC 125.04.

SECTION 3. That Jeanne M. Wannemacher and Ronald N. Miller are hereby authorized to agree in the name of the Village of Ottoville to directly pay the vendor, under each such state contract in which it participates, for items it received pursuant to the contract, and Jeanne M. Wannemacher and Ronald N. Miller do hereby agree to directly pay the vendor.


